

In exchange for Porsche Cars North America, Inc. ("PCNA") allowing you to observe or participate in an event ("Event"), including the occupancy and operation of a Porsche or other vehicle ("Vehicle"), or being permitted to enter for any purpose any "Restricted Area" (defined as any area requiring special authorization, credential, or permission to enter, or any area to which admission by the general public is restricted or prohibited), and for other good and valuable consideration, the receipt of which is hereby acknowledged, you, for yourself and your personal representatives, heirs, and next of kin, do hereby, to the fullest extent permitted by applicable law:

1. Acknowledge, agree, and represent that you have or will immediately upon entering any Restricted Area, and will continuously thereafter, inspect the Restricted Area which you enter, and you further agree and warrant that, if, at any time, you are in or near any Restricted Area and you feel anything to be unsafe, you will immediately advise the officials of such feeling, and if necessary will leave such Restricted Area or refuse to participate further in the Event or to observe it within such Restricted Area.
2. Release, waive, and forever discharge PCNA, its parents, subsidiaries, and affiliate companies, and all rescue personnel, all persons in any Restricted Area, the owners and lessees of the Event premises, promoters, sponsors, advertisers, and all Event inspectors, underwriters, consultants, and others who give recommendations, directions, or instructions, or engage in risk evaluation or loss control activities regarding the Event premises or the Event, and each of them, and all their respective officers, directors, members, shareholders, employees, representatives, agents, successors, or assigns ("Releasees"), from any and all liability to you, your personal representatives, assigns, heirs, and next of kin for all losses or damages and all related claims, on account of injury to you (including death) or your property, arising from or relating to your custody or use of the Vehicle or presence at the Event, whether caused by the negligence of Releasees or otherwise, including negligent rescue operations.
3. Covenant and agree not to commence or maintain suit against any one or more of the Releasees for injuries sustained (including death) or damages incurred and agree to indemnify, save, and hold harmless Releasees from and against any and all loss, liability, injuries sustained (including death), damage, or cost incurred which may arise or relate in any way to your custody or use of the Vehicle or presence at the Event, whether caused by the negligence of the Releasees or otherwise, including negligent rescue operations.
4. Assume full responsibility for any risk of bodily injury (including death) or property damage arising out of or related in any way to your custody or use of the Vehicle or presence at the Event, whether caused by the negligence of the Releasees or otherwise, including negligent rescue operations.
5. Acknowledge that the activities included in the Event are very dangerous and involve the risk of serious injury, death, and property damage, and that any injury sustained may be compounded or increased by negligent rescue operations or procedures of the Releasees.
6. In the event that any portion hereof is held invalid or otherwise unenforceable as a matter of law, agree that the remaining terms shall, notwithstanding, continue in full legal force and effect.
7. Acknowledge and agree that you elected to drive your own vehicle on a closed circuit track as part of the Event and certify that your vehicle is in good condition and fit for the purpose of this Event (including proper tires, no fluid leaking, etc.). You acknowledge that PCNA will not inspect your vehicle to determine whether it is fit for the purpose but shall have the right to reject your vehicle from participation if required for safety or legal reasons, at PCNA's discretion. You agree that you are responsible for your insuring your vehicle prior to participation in the Event and acknowledge that many everyday auto insurance policies do not cover closed track driving. You also agree that you are responsible for any damage to the facility you may cause through your participation in the Event.
8. [FOR CALIFORNIA PARTICIPANTS OR OBSERVERS] Acknowledge and agree that, except as otherwise provided herein, this release is intended to extinguish all claims of every type, including those known and unknown and those suspected and unsuspected, without regard to whether they are now known or suspected, even if those claims may materially affect your decision to enter into this release. This is a full and final release and you expressly waive any right under California Civil Code Section 1542, which provides:  
"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH A RELEASOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS/HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM/HER MUST HAVE MATERIALLY AFFECTED HIS/HER SETTLEMENT WITH THE RELEASE."
9. Acknowledge and agree that in no event shall your custody or use of the Vehicle or participation or presence at the Event deem you an agent, servant, or employee of PCNA, its parents, subsidiaries, or any affiliate company for any purpose whatsoever.

You have read this Release from Liability, **FULLY UNDERSTAND ITS TERMS, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO YOU.**
