

Teen Board Overview

CHRISTIAN CITY'S TEEN BOARD educates young adults about Christian City's mission and what it does to help children who have not experienced a stable, supportive home environment. The Christian City Teen Board offers unique opportunities for teenagers to contribute to the greater Atlanta community in a meaningful way, by learning how a non-profit works and shaping and participating in its outreach efforts, while building resume credits and real-world experience.

To be a Teen Board member, a teen must be attending high school and on target to finish with peer group or have already graduated and be under the age of 19 years old. A Teen Board member must be mature and passionate about helping others and have demonstrated it through past volunteer experiences verifiable by awards, recognitions or letters. Character development is critical for the youth that are served by Christian City and our expectation is that a Teen Board member will have a good report from the people in their local community. Therefore, each candidate will provide references, two from community leaders (pastor, church leader, local appointed or elected official, business owner or employer etc.) and one from a current or former teacher.

A Teen Board member will be required to undergo a local background check. Background checks can be processed at the local police or Sheriff's office and the expense will be reimbursed to Teen Board Member once completed background paperwork is presented to the Christian City representative. Additionally, any teen that is not 18 or above will need a signed parental consent form. Teen Board members will need to dedicate time to attend six meetings per year as well as participate in planning and executing a special event to benefit Christian City.

A term for a Teen Board member will be two years for elected positions (President, Vice President, Secretary and Treasurer) and one year for all other members.

Verification of volunteer hours will be provided and, if requested, letters of recommendation to colleges or employers will be made available.
